

#### **CAROL D. POWELL LEXING**

When Carol Powell Lexing began her career as an attorney, she knew she wanted to help people. But she had no way of knowing that the journey she was embarking on would lead her to become one of the leading civil rights attorneys in the country. She received her J.D. fom Southern University Law Center and soon became a voice for the voiceless, earning the American Bar Association National Pro Bono Coordinator of the Year Award in 1995. As Carol developed her civil rights career, she was soon thrust into the national spotlight because of her involvement in the infamous Jena Six case. Once Carol saw how racially corrupt the system in Jena was, she knew she needed to get involved. After her experience with the Jena Six case, Carol believes that God elevated her to a higher standard.

She took case after case of civil rights issues, including the 2008 Baron "Scooter" Pikes case and the 2014 shooting of 14 year-old Cameron Tillman. Carol has been named by the Congressional Black Caucus as one of the leading Civil Rights Attorneys for the 21st Century. She's been featured in news sources from CNN, The New York Times and Aljazeera to Dr. Phil, Newsweek, and Essence. A woman of great faith, Carol believes her faith is the anchor that allows her to be successful in the important work that she has dedicated her life to. She knows that the system can railroad people if they don't have someone to stand up for them. That's why she has dedicated her career to making sure that all people are treated fairly. She puts her heart and soul into each of her cases, ensuring that her clients receive the most favorable outcome possible and that they always know they have someone in their corner.



#### **DORIS BROWN**

Doris Gray Brown has been a registered nurse for 45 years and has experience in public health, nursing, education and health care administration. Currently, she is serving as the Public Health Executive Director for the Louisiana Department of Health (LDH), Office of Public Health's Bureau for Community Preparedness. During the past fourteen (14) years, she has been instrumental in meeting the planning and training needs of the more than six thousand employees for the Louisiana Department of Health and Hospitals emergency preparedness efforts. She also serves as the Principal Investigator for the Public Health Emergency Preparedness Cooperative Agreement and the Hurricane and Opioid Crisis Grants.

Mrs. Brown was elected to the DREF Board of Directors in 2019. She is the President of the Nonpareil Chapter of the Top Ladies of Distinction, Inc., and serves as the Area Chair of the President's Council and Chair of Health, Wellness, and Safety on the national level. She is currently the Vice President of the Psi Phi Chapter of Chi Eta Phi Professional Nursing Sorority, Inc. She is also a founding member of Louisiana Action Coalition. Doris was one of twenty nurses in executive leadership roles nationwide selected as 2006 Robert Wood Johnson Executive Nurse Fellowship program. Mrs. Brown is a Diamond Life Member of Delta Sigma Theta Sorority, Inc., and has served in several leadership roles in her chapter, Baton Rouge Delta Alumnae, as well as on the state and regional levels. She currently serves as the Southwest Regional Social Action Co-Coordinator. Doris is married to Adell Brown and they have three daughters, Brandy, Ashley, Adele and one grandson, Taylor.



### JESSE B. BILBERRY, JR.

The Rev. Dr. Jesse Bernard Bilberry, Jr. was the first of 10 children born to the Rev. Jesse B. Bilberry, Sr. and Mrs. Joe B. Bilberry in Marion, Louisiana. He was educated in the public schools of Union Parish and attended college at Southern University in Baton Rouge where he finished with a B.A. in Social Studies and English. Pastor Bilberry went on to complete his Master of Education degree at Louisiana State University and finished with a Doctorate of Theology from Christian Bible College. Pastor Bilberry began his working career in the classrooms in Farmerville and Spearsville, Louisiana. The highlight of his educational career was a 13-year tenure as Principal of Tensas Rosenwald High School in St. Joseph, Louisiana. Positions on the Executive Council of the Louisiana Education Association and the Tensas Education Association finally brought him back to the Southern University campus. At Southern, Pastor Bilberry served as the Director of the Freshman Complex, the High School Relations Office, and the Admissions Office.

Pastor Bilberry was baptized at the Blooming Grove Baptist Church in Farmerville, Louisiana, when he was 14 years old. He was a faithful and active member until 1975, when he moved his membership to Mount Pilgrim Baptist Church. He served in many capacities prior to his pastorship, including being ordained as a deacon and acting as head of the Finance Committee. In 1981, Pastor Bilberry accepted God's call to the ministry. He then served as an associate minister until being called as the Pastor of Mount Pilgrim. Rev. Jesse B. Bilberry, Jr., was elected by the congregation on January 16, 1984 to become its eighth pastor. He was both ordained to preach and installed by the Fourth District Missionary Baptist Association on February 19, 1984. Pastor Bilberry has been married to Mrs. Verta Lee (Hamilton) Bilberry of Monroe, Louisiana for more than 50 years. He and his wife have one daughter, Cassandra Gail Bilberry. #### EDWARD C. "TED" JAMES, JR.

State Representative Edward "Ted" James' passion for leadership is driven by a deeply held desire to impact the lives of others while transforming the community he simply calls "home." The Baton Rouge native was taught at an early age the value of service, the strength of community, the importance of a quality education, and the principles of social justice. Upon being admitted to the Louisiana Bar, Ted began his career working in the Office of Governor Kathleen Babineaux Blanco where he was actively engaged in policy reform efforts targeted at establishing affordable housing solutions across the state of Louisiana. As the Governor's policy advisor on housing and community development Ted assisted in securing a \$25 million investment into the Louisiana Housing Trust Fund. Ted later served on the Louisiana Commission on Housing and Community Development, where he continued his dedication to establish affordable housing solutions for the people of Louisiana. Under the leadership of Governor Blanco, he dedicated himself to the revitalization and rebuilding of Louisiana the aftermath of Hurricanes Katrina and Rita 2005.

Upon completing his service in the Blanco administration, Ted worked as a staff attorney with the Louisiana House of Representatives. His tenure as a staff attorney helped to provide him with the unique perspective and insight he uses today in his service as an elected member of the body. In 2009, Ted was appointed to serve as Special Counsel to the Secretary of the Louisiana Department of Revenue where he was charged with developing the Department's legislative strategy. His leadership led to an appointment by Governor Bobby Jindal to serve on the Louisiana Advisory Commission on Intergovernmental Relations where he effectively managed relationships with other governmental agencies to further the well-being of the people of Louisiana. In November of 2011, Ted James was elected to serve as Louisiana State Representative for District 101. Through his hard work and dedication, Ted immediately emerged as a leader in the Louisiana Legislature. In 2016, he committed himself to recovery efforts following the historic Baton Rouge flood. He currently serves as Chairman of the Administration of Criminal Justice Committee. Representative James is an avid supporter of public education and healthcare for all citizens. He prides himself on being a voice for the working people of Louisiana.

In addition to his legislative duties, Ted's professional work extends to his role as an attorney, adjunct law professor, and Director of the Baton Rouge office of the Urban League of Louisiana. He enjoys partnering with various not-for-profit organizations where he is dedicated to giving back to the community by committing countless hours to mentoring students in Baton Rouge schools and sharing his acquired wisdom and knowledge by way of public speaking throughout the state of Louisiana. Ted has received a number of honors and awards for his work and service. Most notably, he is the recipient of the Baton Rouge Business Report's "Forty Under 40" award and the National Chapter of the NAACP's "Top 40 Power Players under 40" award. He was also named to the National Bar Association's 2013 Nation's Best Advocates: 40 Lawyers Under 40. State Representative James earned a Bachelor of Science degree in Accounting from Southern University A & M College and went on to obtain his Juris Doctorate with honors from the Southern University Law Center where he also served as the President of the Student Bar Association. He is an active member of Beacon Light Baptist Church and Kappa Alpha Psi Fraternity, Inc. He is the proud father of his daughter, Harper Ryan James.



#### SADIE ROBERTS-JOSEPH (POSTHUMOUS HONOREE)

Sadie 'Armstrong' Roberts-Joseph (affectionately called Ms. Sadie), the 6th child of 12 siblings (6 girls/6 boys, the Delightful Dozen), was a native of Woodville, MS. Graduate of Sevier High School, Ferriday, LA and Our Lady of the Lake (OLOL) School of Professional Respiratory Therapists. She was a great friend and neighbor. Some of Sadie's most outstanding and noticeable qualities were her speech, love for the African culture, caring spirit and persistent mannerism. She spoke very eloquently at all times, even when disgruntled. Rarely was she seen without being adorned in breathtaking apparel of African accent. Oh, but she was so much more. She was a Respiratory Therapist by profession. She was such a caring person and had a passion for sick people. When someone became ill, especially a family member, Sadie would definitely come to your rescue and do whatever necessary to restore you back to mint condition. She was considered the "caregiver" of the family. She always asked questions and demanded a sensible answer; then would formulate a workable solution to help either solve or improve the problem. She was an advocate of education and believed that all should learn their history. She was the drum major for educating our children, both academically and socially. She loved the neighborhood school, Banks Elementary and fought very hard to keep it operating.

Sadie's community involvment included: Organized CADAV, Inc. (Community Against Drugs and Violence). Instrumental in the existence of the Kelly Community Center, Instrumental in the recognition of Juneteenth as a National Holiday in Louisiana, and becoming the Founder and Curator of Odell S. Williams Now and Then African American Museum Goal for the Museum: To educate the people of the history of African Americans because knowledge is understanding. Motto: "You have to know from whence you came in order to know where you are going. Take a Step Back in Time and Leap Into Your Future!" ### **HONOREES**



#### **CLEO FIELDS**

Born in Baton Rouge, Louisiana, on November 22, 1962, Cleo was one of 10 children of Isidore Fields, a dockworker, and Alice Fields, a maid. Isidore died after falling asleep behind the wheel of his car on his way home from working a double shift. Poverty became a way of life for four–year–old Cleo, as the Fields household struggled to make ends meet. "I didn't know what poor was," Cleo Fields later recalled, "I thought mommas were supposed to put three patches in a pair of pants. In junior high school, it really hit me in the face. That's when I realized what my mother was going through". At one point, the family was evicted from a Baton Rouge apartment. Throughout his youth, Fields worked several jobs to aid his family, taking a shift at a fast food restaurant and working at the Baton Rouge mayor's office of youth opportunity to save money for college.

After graduating from McKinley High School (1980) in Baton Rouge, Fields attended cross—town Southern University, earning his bachelors and law degrees (1984). Politics became his passion. In his early law school years, he began circulating bumper stickers to classmates that read, "I'm waiting for Cleo Fields." Fields noted, "I didn't know what office I would run for, so I didn't want to be too specific." In 1987, Fields obtained his law degree from the Southern University Law Center. Upon completion of law school, Fields was elected to the Louisiana State Senate at the age of 24. He became the youngest person ever elected to the State Senate in Louisiana's history and at that time, the youngest in the nation.

In 1992, Fields was elected to the U.S. House of Representatives, representing Louisiana's 4th Congressional district. At the age of 29, Fields was the youngest member of the 103rd Congress. In 1993, he created a Congressional Classroom for elementary through secondary school-age students. Noted for being the first of its kind in the country, the Congressional Classroom helped students develop leadership and self-esteem while understanding the governmental process. It is known today as the Louisiana Leadership Institute.

In 1995, he made a bid for Governor of Louisiana, leaving a historical mark by becoming the first African American since reconstruction to make the runoff. He then went on to complete two terms as Congressman. On December 13, 1997, Fields returned to the 14th Senatorial District of Louisiana and served until 2008. On October 12, 2019, Fields was re-elected to the 14th Senatorial District of Louisiana, making history again by becoming the first person in Louisiana to return to the Senate for the third time.

Fields is a member of the Mt. Pilgrim Missionary Baptist Church. He is married to Debra and they have two sons, Brandon and Christopher.



#### MARK AND DAWN MALVEAUX

Mark Malveaux graduated magna cum laude from Southern with a Bachelor of Science degree in economics in 1989. While at Southern, Malveaux was the first student in the University's history awarded the Harry S. Truman Scholarship. He was also named the "Outstanding Student in the College of Business." He then attended the University of Virginia School of Law, where he received his Juris Doctor in 1992. While in law school, Malveaux was also awarded the Bracewell and Patterson Oral Advocacy Award.

Upon graduation, he began his law practice at an international law firm. At the public finance firm of McCall, Parkhurst and Horton, he became the first Black partner at a nationally recognized public finance firm in Texas. An active angel investor, Malveaux is currently on the advisory board of technology firm Filtari and a significant investor in specialty pizza company Zalat Pizza. He is also on the board of directors for the \$2 billion Dallas Police and Fire Pension Fund.

Dawn Dillion Malveaux graduated with a Bachelor of Science degree in computer science in 1984. Dawn Malveaux is a third-generation Southern University alum with her late grandfather graduating in 1935. Upon graduation, she enjoyed a nearly 20-year career in computer science before devoting her time and energy to her two children, Jordan and Dillon. She is an active member of her sorority, Alpha Kappa Alpha Sorority, Incorporated, and enjoyed her time as an active member of Jack and Jill of America.

"Dawn and I owe so much not only to Southern University but also to the communities that nurtured us," Mark Malveaux said. "This gift is a tribute to a great university and the people who have committed themselves to uplift, including my amazing economics professor, the late Dr. Fred Temple. The gift is also a recognition of our parents and those aunts and uncles who did not have the opportunity to complete high school. They sacrificed much for my generation and set an example of humble dignity."




